	NATURE OF PROVISION OF DATA	The personal data you provide is collected by us on a voluntary basis but it is necessary to allow you to participate in our events. If you do not provide the data, we may not be able to allow you to register and/or participate to our events, winning prize events or exhibitions
	CATEGORIES OF DATA RECIPIENTS	The data may be disclosed to external subjects in their capacity as data controllers, such as banking and credit institutions, insurance companies, self-employed professionals (law firms, notaries and accountants), authorities and supervisory and control bodies and, in general, public or private entities entitled to request personal data. Data may be processed on behalf of the Data Controller by external parties (persons, companies, associations or firms) appointed as data processors, who are provided with appropriate operating instructions. These parties fall into the following categories: a. companies that offer maintenance services for websites and computer systems; b. companies that carry out market research services; c. companies that provide management and maintenance services for the Data Controller's database; d. companies that offer e-mail management services; e. companies that provide management services for the marketing automation platform; f. companies that provide organizational and/or technical support to the organization of the event, prize winning events or to the exhibition (for example, services for ticket sales and reception services for events); g. companies assigned to conduct the prize-winning events.

	DATA SUBJECTS RIGHTS	You can exercise the rights recognized to you by the relevant legislation including the right to obtain access, rectification and update or erasure of your personal data, as well as to request restriction of processing, portability and to object to the processing, specifically on legitimate grounds. For processing based on consent, you have the right to withdraw your consent at any time. The data subject DECLARES to have nothing to claim from the Company for any reason and/or title directly related to the publication of the above-mentioned images and/or video reproductions and to hold the Company harmless from any request and/or claim that may be made on this matter, even by third parties.

The consent is collected in a point & click mode in the form provided for the registration.
